Ready, Set, Grow!

New Developments Coming to Upper Uwchlan

Take a drive through Upper Uwchlan and you're likely to encounter new construction.

What you may not know is the process developers go through when proposing a project. Here's a simplified explanation, which may help residents understand how and why different developments - subject to the Township's Subdivision and Land Development (SALDO) ordinance - come to be. Many developments may require a series of approvals, including Conditional Use, Zoning Hearing, Subdivision Plan, Preliminary Land Development Plan, Final Land Development Plan. All subdivision/land development plans also have to be reviewed by the County Planning Commission, and when any new sewer systems are involved, the County Health Department and PA DEP.

The Planning Commission. The first stop for proposed SALDO development is the Township's Planning Commission. Appointed members of the Planning Commission are volunteers who are responsible for reviewing and evaluating subdivision and land development applications, providing guidance and issuing recommendations to the Board of Supervisors. Critical in its evaluation role, the commission's task is to ensure that all development occurring within the township adheres to the community's zoning and land development ordinances and meets the spirit of its Comprehensive Plan. *For more information, check out the UUT Code §162-8.*

The Comprehensive Plan.

The Township "Comp" Plan is the official account of a municipality's planning goals. The document guides future development - proposed projects are evaluated against the Plan's goals and objectives. The most recent Comp Plan was developed in 2014 with assistance and expertise provided by Brandywine Conservancy and other Township consultants. The Plan is a direct result of the time and effort expended by the township's Board of Supervisors, Planning Commission, and staff. Members of these groups spent a considerable amount of time analyzing data, hearing public input, and discussing the most appropriate methods for managing the township's future growth and protecting its resources.

Board of Supervisors.

Next stop: The elected Board of Supervisors. "Upon receipt of the Planning Commission's recommendation and other supporting information, the Board shall, at one or more regular or special public meetings, review the final plan and shall, within the time limitations set forth hereinbelow, either approve or disapprove the plan. §162-8B(2)(c)[2]"

Attending public meetings is a great way for residents to stay updated on proposed and approved developments in the Township.

You can also keep up by reading the minutes of these public meetings, which are archived on the Township website, www.upperuwchlan-pa.gov. Please note that the above process is far more complex than explained here - check out the resources above to learn more!

Current Developments:



The Reserve at Chester Springs

62 single-family home development along Little Conestoga Road.

The Townes at Chester Springs

40 townhomes located along Park Road between Little Conestoga Road and Heather Hill Drive.

Village at Byers Station

Located along Station Boulevard between Graphite Mine Road and Pottstown Pike. Construction on the residential portion - consisting of 121 townhomes - is underway.

The southern portion of the site will consist of commercial/retail space of up to 75,000 square feet. The development of this mixed-use parcel initially received approval in 1999 and various concepts have been proposed through the years.

Marsh Lea

27-home development on Little Conestoga Road at the Wallace Township boundary, with 21 homes in Upper Uwchlan and 6 in Wallace.

McKee-Milford Associates

This Active Adult Community for those 55 years old and older was approved in October 2017 and proposes 114 single-family homes, 156 twins, 105 triplexes, a clubhouse, and amenities. The Developer is in the process of acquiring permits from outside agencies.





Trash and Recycling

As a reminder, Upper Uwchlan collects trash using an automated collection truck, with each collection limited to one (1) trash Toter issued by the Township. Please place your trash and recycling Toters at the curb, the night before collection, three (3) feet apart and three (3) feet from any immovable objects, such as motor vehicles, mail boxes, etc. Bulk pick-up is the 3rd pickup of the month.



Do you have only the one 64 gallon recycling Toter originally issued by the Township? Do you need additional recycling capacity? In an effort to emphasize single stream recycling and make it as convenient as possible, the Township will either swap your 64 gallon recycling Toter with a new 96 gallon recycling Toter or issue you an additional recycling Toter, all at no additional cost to you. If you are interested in additional recycling capacity, please call 610-827-6033 to discuss your options.



All recyclables are to be placed directly into the recycling toter.

DO NOT place recyclables into non-recyclable plastic bags then put into toter. The hauler WILL NOT take your recycling if it is enclosed in a non-recyclable bag inside you're recycling toter.

Recyclable materials include:

aluminum products, glass, plastic, cardboard, newspaper, magazines, periodicals, bulk mail, phone books.

Reminder: The Township is no longer legally allowed to collect e-waste such as televisions, computers, etc.

The burning of recyclable materials, to include yard waste, trees, shrubs, leaves, garbage, etc. is strictly prohibited. Burning permits are no longer issued.

Compost Lawn and Leaf Collection:

These collections are composted. Use biodegradable bags or open containers (no lids). Do NOT use plastic bags. Yard waste in plastic bags will not be collected. Tree limbs/branches must be bundled with twine no larger than 3' x 3' bundles, or placed in open containers with no lids. Bags are available for purchase at the Township building.

Did you know that 2018 will be the 25th anniversary of DARC's founding? We've been around for so long that, to most of our residents, DARC gets taken for granted. As we look back and celebrate this milestone we wanted to share with you our history and purpose.

What is DARC?

D.A.R.C. is short for the Downingtown Area Recreation Consortium. We serve the recreational needs of over 69,000 residents made up of 40,000 households. DARC is the largest recreational provider in Chester County. We are an independent organization (Council of Government) that was created by the eight municipalities that make up the Downingtown Area School District. We are governed by a Board made up of representatives from each member municipality and one from the School District.

When Chester County was growing rapidly 25 years ago, our municipalities had the foresight to think ahead. It was decided that each municipality would focus on what they did best – provide parks and local community based events. But it was determined that it would be much more efficient – from a tax dollar perspective and in cheaper recreational costs to the residents – to form an organization that served the recreational programming needs of everybody in the school district.

Because of our size we are able to provide a much broader range of recreational opportunities than any single municipality could. We are able to keep our programming costs down because our municipalities and the school district graciously provide spaces to run our programs in. We are also able to negotiate with outside, for-profit recreational providers for better program rates for our residents.

We do all this, each and every day, at an annual cost in tax dollars to your municipality of less than \$1 per person. That's a bargain anyway you look at it.

Township Receives Awards for PSATS

Upper Uwchlan Township's efforts to keep its residents updated and informed about the community have earned the municipality two awards in the Pennsylvania State Association of Township Supervisors' (PSATS) 50th Annual Township Citizen Communication Contest. The annual contest recognizes townships that have successfully communicated programs and activities to citizens.

Upper Uwchlan received first place in the Class 1 Newsletters category (for townships with populations over 10,000) and second place in the Most Improved Newsletter category.

The contest attracted entries from across the commonwealth in eight categories, including printed and electronic newsletters, most improved newsletters, other publications, audiovisual communication, cable TV programs, social media, and websites. In all, 40 townships submitted 99 entries for this year's competition, and 20 individual townships won awards.

All contest entries were judged on the usefulness of information presented and how well the information was communicated to township residents. Publications were also judged on their overall attractiveness and readability.

Judges included members of the association's standing committees and PSATS staff.

The Pennsylvania State Association of Township Supervisors represents Pennsylvania's 1,454 townships of the second class and is committed to preserving and strengthening township government and securing greater visibility and involvement for townships in the state and federal political arenas. Townships of the second class represent more residents — 5.5 million Pennsylvanians — than any other type of political subdivision in the commonwealth.

Alert To Residents Whose Taxes are Escrowed and Paid as Part of a Mortgage Payment

If you have not already done so by now and your taxes are part of your mortgage payment and are paid for you by a third party,
PLEASE ALERT THE CUSTOMER SERVICE DEPARTMENT

OF THAT ESCROW AGENT THAT YOU HAVE A NEW TAX BILL!

Residents in this situation should do this before doing anything with the bill. The phone number of customer service is usually right on the mortgage bill. This should give the homeowner peace of mind knowing that the bill has been received and is in the process of being paid. After that, the resident should be able to track their payment through their escrow account with the mortgage company to verify payment has indeed been made.

Please realize that I am required to send the Upper Uwchlan Township tax bills to the owners listed as deed holder by Chester County. I do not send them to the mortgage company directly although I have established electronic relationships with some of the bigger ones to do that. But every resident is sent a bill.

When you get your bill, if your taxes are escrowed, **call the escrow company and ask if they need the bill!** If you have any questions for me as Tax Collector, please email me at blagarde2@gmail.com

PECO Infrastructure Upgrades

PECO crews will be working along Pottstown Pike Upper Uwchlan Township between February and August 2018 to upgrade the infrastructure of the local electric distribution system.

This is part of PECO's System 2020 plan to "make it more weather resistant and less vulnerable to storm damage." Work will take place along Pottstown Pike (Route 100) in the northernmost part of the Township. Work along state roads is expected to take place between 9 am and 3 pm. In April, crews expect to begin working on electrical equipment, in some cases installing new poles and aerial wires.
