By the time this newsletter reaches you, the long-awaited Park Road Trail extension will be nearly complete! The trail extension, 0.83 miles in all, is a pedestrian connection extending west from Hickory Park to Marsh Creek State Park. From Hickory Park, pedestrians can find trails to Eagleview, to the Village of Eagle, to Upland Farms, and beyond to many of the residential neighborhoods in the Township.

The work along Park Road also included a reconstruction of the roadway and installation of new stormwater management features.

Park Road was identified in the 2005 Trail Network Master Plan as a popular route for both pedestrians and bicyclists. It was also identified as a road that was, at that time, unsafe for those activities. In the 14 years since then, multiple phases of construction have led to a complete pedestrian connection the length of Park Road.

### A Network of Trails

The development of community trails has been part of Upper Uwchlan Township's recreation and planning policy since the adoption of the Open Space, Recreation and Environmental Resource Plan in 1992. As that plan notes, "Trails are an important component of the Township's park and recreation network. They

provide a means to walk or bicycle to recreational facilities and other destinations within the Township."

The Trail Network Master Plan, developed in 2005, outlines the conceptual vision and construction cost estimates for community trails in Upper Uwchlan. These include paved multi-use trails, side paths and sidewalks, signed walking streets and bike routes, hiking trails, and bike lanes. Many of the trails envisioned in that plan have been installed. Stop by the Township office for a handheld map of the trails on the ground!

A recent survey of Upper Uwchlan Township residents found that trails – for hiking, biking, and fitness – are the enhancement that would most increase resident satisfaction with parks and recreation in Upper Uwchlan Township. The Township continues to work to expand our trail network and make connections to both new and existing developments.

### Where to next?

Additional connections in the Upper Uwchlan Township Trail Network are coming soon!\* A trail network as large as Upper Uwchlan's takes time to develop and is built piece by piece. Many of the trails and trail sections described below are part of residential and commercial development.

- **Chester Springs Crossing**  
Milford Road and Pottstown Pike across from Windsor Ridge – interior sidewalks and trails along Milford Road.
- **McKee Development**  
Milford Road – interior trails and sidewalks throughout connecting the new residential development to the Reserve at Eagle to the northeast and to the Reserve at Chester Springs to the south; trail along Milford Road at the frontage of the development.
- **Villages at Byers Station and Parcel 5C**  
interior sidewalks and trail connections to the trail along Station Boulevard.
- **Fieldstone at Chester Springs** at Byers Road and Graphite Mine Road – trail connection to The Mews at Byers Station.
- **Marsh Lea** Little Conestoga Road – interior sidewalk, trail connection with the Brandywine Trail along the northwest side of Marsh Creek Lake.
- **Profound Technologies** Little Conestoga Road at Pottstown Pike – trail or sidewalk across property frontage.
- **Eagleview** Sierra Drive – trail connection to Pondview Way.

In addition, the Township has been working for many years with PennDOT and the Pennsylvania Turnpike Commission to incorporate trail connections into the bridge and overpass construction related to the Turnpike Expansion.

# Upper Uwchlan Township Building:

## UNDER CONSTRUCTION

### Renovation and Addition

The Upper Uwchlan Township municipal building, located at 140 Pottstown Pike in the Village of Eagle, houses the township administration offices and the Police Department. The building has been expanded 2 times; first in 1987 when the original addition was made to the historic schoolhouse, and again in 1998. As residents have no doubt noticed, a third expansion of the building is now underway.

Residential and commercial growth in the Township has accelerated in recent years. The population of the Township is expected to reach 12,179 by 2020. As our Township has grown, so too have the staff and services of the Township administration and police department. The expansion will accommodate both current staff and expected future expansion of staff and services.

The design adds 2,697 square feet of office space to the upper level administration offices and 3,377 square feet of space to the Police Department on the lower level. The historic schoolhouse, where public meetings are held, will not be altered or expanded.

### Temporary Relocation

During construction, the Upper Uwchlan Township Administration office and Police Department have relocated.

### FAQs

**Can I still call the Township office?** Yes, the telephone numbers have not changed.

**Where will public meetings be held?** Unless otherwise advertised, public meetings are held at the Administration office, 415 Eagleview Blvd., Suite 116, Exton, PA 19341.

**Where should I mail my sewer/trash payment?** The mailing address for payments will stay the same: P.O. Box 437, Uwchland, PA 19480. Bills may be paid in person at the 415 Eagleview address. OR pay online! Visit [upperuwchlan-pa.gov](http://upperuwchlan-pa.gov) and click the online payment button on the home page.

**Will there still be a payment drop box?** Yes! There is a payment box at the relocated administration office, at 415 Eagleview Blvd., and at the relocated Police Department at 520 Milford Road (the southwest corner of Milford and Little Conestoga.)

**Can I still drop unneeded prescriptions at the Police Department?** No, the medication return program will be suspended while the Police department is in the temporary location. Nearby West Vincent Township has a medication take back box at the Police Department, located at 729 St. Matthews Road.

**When will the offices return to the Township Building?** The renovations are expected to be complete in the Spring of 2020.

# Recycle Right!

## Curbside Single Stream Recycling

Toss these items directly into your Recycling Toter. **DO NOT** use plastic bags.

**PAPER** Newspapers, cardboard, paper bags, magazines and junk mail, phone books, home/office paper, paper egg cartons, rinsed milk and juice cartons, clean pizza boxes, and boxboard food packaging. Break down and flatten.



**PLASTIC** Containers marked #1—#5 and #7. Throw away caps and lids. Rinse thoroughly.



**METAL** Food and drink cans, pie plates, clean aluminum foil. Rinse thoroughly. Empty aerosol cans.



**GLASS** Clean food and drink bottles and jars. Throw away lids. Rinse thoroughly.



## For the Garbage Toter



**TRASH** Food waste; light bulbs; mirrors, plate glass, window glass, drinkware and crystal; ceramic cups and plates, flower pots, ovenware; caps/lids from recyclable containers; empty paint cans, empty oil cans and bottles; plastic food wrappers, plastic bags; wax or plastic coated boxes/paper, plastic and Tyvek envelopes; straws, tissues, towels, napkins, plasticware; Styrofoam/polystyrene; shoes and clothing; metallic wrapping paper.



## Trash & Recycling

UUT Toters are your **PRIMARY** containers for trash and recycling collection. Place Toters at the curb the night before your collection day, and at least 3 feet apart and away from mailboxes, cars and other obstacles.



Bulk pick-up is the 3rd pick-up of the month.

**DO NOT PUT CLEAN RECYCLING INTO PLASTIC BAGS – THEY ARE NOT RECYCLABLE!**

Recycling is to be put directly into the recycling totter, **UNBAGGED**. If you put in plastic bags, it does not go into the single stream recycling, it's contaminated and goes to **TRASH**, **DEFEATING** the purpose of recycling and not helping the environment. Styrofoam is not recyclable.

**SEE Chart for proper handling of recycling!**

Do you have only the (1) 64 gallon recycling Toter originally issued by the Township? Do you need additional recycling capacity? In an effort to emphasize single stream recycling and make it as convenient as possible, the Township will either swap your 64 gallon recycling Toter with a new 96 gallon recycling Toter or issue you an additional recycling Toter, all at no additional cost to you. If you are interested in additional recycling capacity, call 610-827-6033 to discuss your options.

**All recyclables are to be placed directly into the recycling totter.**



**Recyclable materials include:**

aluminum products, glass, plastic, cardboard, newspaper, magazines, periodicals, bulk mail, phone books.

**Reminder:** The Township is no longer legally allowed to collect e-waste such as televisions, computers, etc.

**Please note:** Yard waste is not considered trash and should **NOT** be put in with your trash. Use open containers (NO Attached lids) or brown compost bags. If yard waste is put in trash totter, it will not be taken.

**The burning of recyclable materials, to include yard waste, trees, shrubs, leaves, garbage, etc. is strictly prohibited. Burning permits are no longer issued.**

## Compost Leaves and Yard Waste: 36 Collections Annually - Wednesdays

Place leaves, grass clippings and yard waste in biodegradable paper bags or open containers. **DO NOT** use UUT Toters. **DO NOT** use plastic bags; these collections are composted. **DO NOT** overload bags. Tree limbs (no larger than 3" diameter and 3' long) must be bundled with string/twine. Place yard waste at the curb the night before collection to ensure it will be picked up.

Loss of power during a severe weather event can mean we need to be self-sufficient for several days. ## Driver Alert!

Only One Earpiece Allowed



The Pennsylvania Vehicle Code allows a driver the use of one earpiece for telephone use when operating a vehicle.

## MS4 - Water Quality Improvement Program

Upper Uwchlan Township is committed to improving water quality in our watershed and is a part of the MS4 program.

### WINTER DE-ICING

As snow piles up in the winter, we oftentimes turn to salt to melt snow and ice. Salt, however, causes adverse environmental impacts, especially on our streams and rivers. Excess salt can saturate and destroy a soil's natural structure and result in more erosion to our waterways. High concentrations of salt can damage and kill vegetation. Salt poses the greatest danger to fresh water ecosystems and fish. Studies in New York have shown that as salt concentrations increase in a stream, biodiversity decreases. Excess salt can seep into groundwater and storm water runoff. Effective ice control can help prevent excess salt runoff to our waterways.

There are many alternatives to salt including potassium chloride, calcium chloride and magnesium chloride, corn processing byproducts, and calcium magnesium acetate (CMA). Most can be found in your local hardware stores under various trade names, so check the labels for chemical content. While these alternatives can be spread in a dry form or sprayed as a liquid, their best use occurs when they are used with salt. They tend to increase the efficiency of salt thereby reducing the amount that needs to be applied. When over-applied, all chloride compounds can be harmful to the environment. Non-chloride corn byproducts recycled from mills and breweries have been shown to be effective de-icers as well. While they are often advertised as organic or natural, they can have extremely high phosphorus content, a major water pollutant. Numerous studies have shown calcium magnesium acetate (CMA) to be the most environmentally benign de-icer. Many northern states use CMA on roads in sensitive areas (wetlands, endangered species' habitat, drinking water supply, etc.).

A couple of disadvantages with CMA however, is that it does not work well below 25° Fahrenheit and it is the most expensive de-icer. Because all de-icers can be harmful to the environment when applied in excess, the best strategy is to reduce the use of these chemicals as much as possible.

- The first line of defense should simply be to shovel sidewalks and pathways to keep them clear and to prevent ice from forming. Also, consider that salt and de-icers are not effective when more than 3 inches of snow have accumulated.
- Consider the temperature. Salt and calcium magnesium acetate (CMA) have a much slower effect on melting snow and ice at temperatures below 25° Fahrenheit.
- Track winter weather and only use salt and de-icers when a storm is about to come through. If a winter storm does not occur, sweep up any unused material, store, and reuse for the next big storm.
- Apply de-icing products discriminately, focusing on high-use areas and slopes where traction is critical. Apply the least amount necessary to get the job done. This will save money in product costs and will also help minimize property damage to paved surfaces, vehicles, and vegetation.
- Reduce salt and other chemicals by adding sand for traction.
- Become familiar with various de-icing products and wetting agents such as magnesium chloride and calcium chloride, which can improve the effectiveness of salt and reduce the amount needed.
- Plant native vegetation that is salt tolerant in storm water drainage swales and ponds that may receive salt-laden runoff. Not only will these native species have a greater chance for survival, but they will continue to act as an effective buffer for our local waterways.
- Store salt and other products on an impervious (impenetrable) surface, such as a basement floor, to prevent ground contamination. Also store products in a dry, covered area to prevent storm water runoff.
