We have secured four quotes for a commercial grade epoxy floor for the basement level of the Upland Farms Barn. The quotes are as follows:

I have spoke to Reid Murray owner of Floorguard and he sent me pictures of a recent barn floor that he did, and it looked great. My recommendation would be to contract Floorguard to install an epoxy floor at the Upland Farm Barn. 

The primary component to the estimate being provided is the installation of an industrial grade, liquid coating material with full preparation. It is our recommendation that a multi-layer floor system (3 layers) be installed/applied over the existing concrete substrate to improve the aesthetics, ease of cleaning, and provide a solid, sealed, encapsulated surface for your active new rec building. Full Chip system (color TBD)

- Diamond grinding the entire painted to fully prepare the existing slab to receive the new industrial grade, liquid coating system to be applied
- Installation/application of elastomeric sealants where needed to fill voids between pillars/walls and slab surface.
- Detail all areas around drains, mechanical equipment, and other obstacles throughout the space.
- Protect all baseboards and adjoining finished surfaces
- Installation/application of 100% solids Basecoat
- Installation/application of 100% solids $\frac{1}{4}$ " Chip system-Color of choice
- Installation/broadcast of Media layer to create anti-skid properties
- Installation/application of UV/Chemical/Scratch Resistant Topcoat
