**RESOLUTION APPROVING AND ADOPTING AN AMENDMENT TO THE
ARTICLES OF INCORPORATION OF THE UPPER UWCHLAN TOWNSHIP
MUNICIPAL AUTHORITY INCREASING ITS TERM OF EXISTENCE BY 50
YEARS.**

WHEREAS, the Board of the Upper Uwchlan Township Municipal Authority has proposed a certain amendment to its Articles of Incorporation by the adoption of a resolution setting forth the proposed amendment and directing that the same be submitted to Upper Uwchlan Township for approval and adoption.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Upper Uwchlan Township as follows:

The following amendment to the Articles of Incorporation of the Upper Uwchlan Township Municipal Authority, to be set forth in Articles of Amendment to be filed with the Secretary of the Commonwealth, is hereby approved and adopted.

1. Said Articles of Incorporation shall be amended by the addition of a new paragraph to read as follows:

“8. The term of existence of the Authority shall be increased to a date which shall be fifty (50) years from the date of approval by the Secretary of the Commonwealth of Pennsylvania of these Articles of Amendment.”
